

## UCV Pledge Form 2021-2022

### 1. How to complete and submit a pledge form

- Print this UCV Pledge Form, complete side two (as well as a pre-authorized debit [PAD] form and a VOID cheque if using that method), scan the completed forms, and send them as **email attachments** to [ca@vancouverunitarians.ca](mailto:ca@vancouverunitarians.ca) or...
- Mail your completed forms by regular mail to: **Vancouver Unitarians, 949 West 49<sup>th</sup> Avenue, Vancouver, BC, V5Z 2T1, Canada** or...
- **Deliver** your completed forms to the UCV Office at 949 West 49<sup>th</sup> Avenue, or...
- Complete the forms for yourself and **phone or email the UCV Office or a member of the Canvass Team** with the key information. Staff will follow up later for the paperwork.
- Better yet, you can **pledge directly online** using the short link [ucv.im/pledge-form](https://ucv.im/pledge-form).

### 2. Choice of payment options

There are multiple ways you can honour your pledge. (Note that there are additional processing charges for the *Canada Helps* and *PayPal* options.)

**2.1. Pre-authorized Debit (PAD) from your financial institution** - Complete the PAD form that is part of this package. If feasible for you, this is our preferred process.

**2.2. Direct deposit through the UCV [Breeze database](#)**

**2.3. Interac e-Transfer** - Here's how to send an e-Transfer:

- a. Set up Vancouver Unitarians as an e-Transfer payee with your bank.
- b. Email the funds to UCV's main email address: [payments@vancouverunitarians.ca](mailto:payments@vancouverunitarians.ca)
- c. In the memo portion of the document please specify "**Pledge 2021-22**".

**2.4. Text message** – Text to 1 778 771 1707 You'll be asked to set up a link to a credit card, debit card, or bank account. See instructions on the UCV website under [Giving](#).

**2.5. Cheque** - You can pay by single cheque, or by a series of post-dated cheques. If you pay by post-dated cheque, we will hold the cheques until after the date you indicate. Make cheques payable to "Vancouver Unitarians" or "Unitarian Church of Vancouver".

**2.6. Cash** - If you pay by cash, please place the cash in an envelope that is clearly labeled with your name, and mark that you want the funds applied to your pledge. Leave the envelope in the offering basket or deliver it to office admin staff or a Canvass volunteer on a Sunday morning or other time you are at the UCV campus.

**2.7. Credit card through *PayPal*** (processing fee has been 1.6%)

**2.8. Credit card through *Canada Helps*** – (processing fee has been 1.6%)
