Commentary: The Finance Committee (which includes the Treasurer, Bookkeeper, Congregational Administrator, and several volunteers with varied financial backgrounds) has been reviewing proposed UCV policy and procedure changes for management of both charitable and refundable Refugee Funds for which the Refugee Team is the approved Fund Oversight Authority. George Myers has been leading the development of these P&Ps on behalf of the Refugee Team. At this time, we have not yet learned whether IRCC (Immigration Refugees and Citizenship Canada) will require annual audits or only every few years when Sponsorship Agreement Holders (SAHs) are approved. The proposed Bylaw change would give the Board flexible authority over this decision whatever the requirements of the IRCC are. Whenever a full audit is required the estimated additional costs to UCV would be approx. \$6,000. (Keith Wilkinson, Chair, 2022 Finance Cmte)
